The permit holder is to adhere to and follow the requirements of the *Agricultural Operation Practices Act* (AOPA) and the regulations passed pursuant to that Act.

The permit holder is to adhere to the descriptions contained in Decision Summary LA05023B, Approval LA05023, and Authorization and LA03046 together with the site plans, and other attached documents.

Operating Conditions (carried forward from Approval LA05023A):

Manure storages

1. The NRCB is to be notified immediately if there is an overflow or leak from any of the manure storages.

Manure application

- 2. Manure must not be spread on frozen or snow-covered ground.
- 3. All liquid manure shall either be direct injected or irrigated followed by incorporation within 48 h or the application of one inch of straight irrigation water. All setbacks to common bodies of water, including natural drainage courses, must be adhered to.
- 4. Solid manure applied to cultivated cropland must be incorporated within 48 hours of spreading.

This approval becomes effective immediately. The approval conditions will remain in effect unless amended by the NRCB.



Approval LA05023A is therefore superseded, unless Approval LA05023B is held invalid following a review and decision by the NRCB's board members or by a court, in which case Approval LA05023A will remain in effect.

Construction Conditions (brought forward from LA03046)

- The solid EMS must be constructed according to the submitted plans.
- Density testing must be carried out on the liner of the solid EMS and the results submitted to the NRCB prior to the use of the facility.
- The concrete manure storage must be constructed according to the submitted plans.
- The applicant must provide a completion report signed by a qualified professional verifying the barn floor was constructed according to the submitted plans.
- Construction must be completed by December 31, 2005.
- The manure storage portion of the barn and the solid earthen manure storage must be inspected by the NRCB prior to animals or manure being placed in the new barn or manure being placed in the new solid manure storage.
- The applicant must provide the Approval Officer a minimum of 10 working days' notice prior to the applicant's desired completion inspection.
