## Notice of Filed Requests for Board Review and Rebuttal Opportunity Decision Summary LA19032 / Corner's Pride Farms Ltd.

The Natural Resources Conservation Board (the Board) has received four requests for review (RFR) on NRCB Decision Summary LA19032 / Corner's Pride Farms Ltd. The decision summary, issued on October 28, 2020, granted an approval for the construction of a new feedlot confined feeding operation (CFO). The CFO location is NE 7-7-20- W4M in Lethbridge County.

The RFRs were filed pursuant to section 20(5) of the *Agricultural Operation Practices Act* (AOPA), and met the November 19, 2020 RFR filing deadline set out in the approval officer's cover letter to the decision summary. A copy of the RFRs received is attached.

Any party who believes they would be adversely affected by the position presented in the RFR may submit a written rebuttal for the Board's consideration [section 13(4) of the AOPA Administrative Procedures Regulation]. Rebuttals must be provided by email to <u>laura.friend@nrcb.ca</u> no later than **4:30 p.m. on November 26, 2020.** Rebuttals filed after the deadline will not be considered.
