RE: Application Notice LA19032 - Corner's Pride Farms

Your letter states that as a courtesy you are notifying all parties within 1.5 miles of the proposed site of the feedlot. It is our opinion the notification distance should take into consideration all affected lands for the proposed site, including the hayfields. We are .3 of a km west of the southwest corner of the hay ground bordering township road 70 and it is our opinion that we will be directly impacted in a number of ways:

- Waste disposal of fecal matter will be spread on the hay fields adjacent to us –causing a stench that will make it virtually unpleasant to be outdoors on our deck or in the yard
- The oiled road Township Road 70, also known as the correction line road, isn't built to handle the increased volume of heavy truck traffic. The County of Warner has spent thousands of dollars in the past year to oil the road and to maintain it – the heavy trucks are breaking it up as fast as they can repair it – more trucks are going to cause more breakup at more cost to the County of Warner taxpayers.
