# **Muilwijk Hearing Details**

The Board released NRCB Decision RFR 2021-02 on February 24, 2021, directing that this matter proceed to an oral (virtual) hearing. This letter provides further details on the hearing process. I have also attached the NRCB fact sheet, *What to Expect at an AOPA Hearing*.

### **Hearing Date and Format**

The hearing is scheduled for April 20, 2021, commencing at 9:30 a.m. In the event the hearing requires additional time, parties are to be available on April 21, 2021.

Parties who have received this letter will receive an email on April 19, 2021 from MNP (NRCB virtual hearing host) with a link to connect to the hearing via the Zoom platform. Parties should **join the hearing at 8:45 a.m. on April 20, 2021,** to ensure that they are online for the 9:30 a.m. start. Video should be turned on during the opening of the hearing. For the remainder of the hearing, mute your microphone and turn off your video unless you are called upon. If you are unfamiliar with the Zoom platform or have other technical questions, please contact me.
