Important notes on the Application Record

NOTE 1. The Board in its RFR2021-02 decision directed the Approval Officer to make the complete application record available (at p 6). Many of the records may not be relevant to the hearing issues.

The Application Record includes many documents that are already part of Technical Document LA19036. The Application Record Index indicates where the document appears in the Technical Document.

With the five exceptions noted below, the Application Record contains all the records in application file LA19036 that

- 1) the Approval Officer is aware of and can locate, and
- 2) is dated between the Part 1 application (Aug. 14, 2019) and the permit decision (Jan. 14, 2021).

Exception 1: Miscellaneous neighbour correspondence. The Application Record includes responses to the public notice from directly affected individuals (John Green, Terri McCullough, and Dean and Hannah Brauer). The Application Record does <u>not</u> include other correspondence between the Approval Officer and these directly affected individuals. That correspondence is not relevant to the hearing issues and the individuals likely did not expect their correspondence with the Approval Officer (other than their written response) to be made public. This correspondence is:

Exception 2: Neighbouring landowners. The MD Willow Creek provided the NRCB with mailing addresses and names of owners of or residents on land within the notification radius. As this is personal information and as the identity of these neighbouring landowners is not in issue, the list of mailing addresses and names (called "LA19036 adjacent landowners" in the CFO database) is not part of the Application Record.

Exception 3: Draft ERST information. The Approval Officer's decision issued January 14, 2021 relied on site information and results from an environmental risk screening tool (ERST) that were generated on December 9, 2020. For that reason, the Application Record does not include either:

- a) January 17, 2020 ERST information entered by the original approval officer from a site visit on September 17, 2019; or
- b) December 3, 2020 site information on the protective layer, and on groundwater resource and uppermost groundwater resource, compiled by NRCB environmental specialist Scott Cunningham. These turned out to be drafts as the Approval Officer and Mr. Cunningham updated some information from the Approval Officer's site visit of November 4, 2020.

Exception 4: June 18, 2020 report. The Approval Officer did not rely on the June 18, 2020 Wood completion report, as he relied on the more recent November 6, 2020 Wood report. While the June 18, 2020 Wood report appears in the application file in the CFO database, and is mentioned in the RFR dated February 4, 2021 (at page 3), the Application Record does not include this record. Please see the Field Services Submission (provided separately) for a copy of the June 18, 2020 Wood report.

Exception 5: TAG RCC Report. The Technical Advisory Group ("TAG") is made up of representatives from the NRCB, Agriculture & Forestry and industry. The Approval Officer, Andy Cumming, is a member of TAG. In May 2020, TAG chartered a project for a working group to determine whether there was "sufficient scientifically based information to support the development of a TAG guideline for the construction and maintenance of RCC as a liner under the Standards and Administration Regulation." The report from that project ("TAG Working Group RCC report") came to Mr. Cumming's attention on December 23, 2020 (as reflected in the database entry on that date – see Document 7) in his capacity as a member of TAG. However, the Approval Officer did not use or rely on the TAG Working Group RCC report when coming to his decision, for reasons provided at page 5 of Decision Summary LA19036. As a result, the TAG Working Group RCC report is

not part of the Application Record. Please see the Field Services Submission (provided separately) for a copy of the TAG Working Group RCC report.

NOTE 2. The Application Record does not catalogue an exhaustive or 100 percent complete record of all the correspondence (phone calls, e-mails, letters) exchanged related to Application file LA19036. For example, transitory records may have been deleted.

NOTE 3. The description of records in the Application Record Index is for convenience only and should not be taken as an interpretation or position on the record.

NOTE 4. Redactions (in solid black) cover personal information that is not necessary to the hearing issues.

NOTE 5. Database screenshots (Document 7): The CFO2 database entries in the screenshots relating to phone calls do not purport to be a verbatim or complete record of what was said during a phone call. Similarly, the database entries in the screenshots relating to site visits are likely not a verbatim or complete record of all interactions and observations at the site. In the database screenshots:

AS = Adria Snowdon, original approval officer AC= Andy Cumming, Approval Officer SG = former Lethbridge field office administrator SK = Sylvia Kaminski, Lethbridge field office administrator

Steps taken to assemble the Application Record:

- Review of the NRCB's CFO2 database for the CFO at NE 10-09-27 W4M, for permits issued before the Part 1 application in LA19036 was filed. This includes municipal development permits (Documents 1, 2, 3 & 4) and two NRCB-issued permits (Documents 5 & 6).
- 2) Review of the database entries (Action tab) for Application LA19036 and compilation of screenshots of entries.

- 3) Review of the database documents (Documents tab) for Application LA19036.
- 4) Access to archived "received" and "sent" e-mails for Adria Snowdon dated August 14, 2019 to May 1, 2020 (with assistance from NRCB's IT services provider), checking for any related to file LA19036. Document 29, for example, shows yellow highlighting of "Adria" as a function of a search term.
- 5) Inquiry of NRCB environmental specialist Scott Cunningham for documents that he relied on during his assistance on file LA19036, other than what is in the CFO database or Technical Document LA19036.
- 6) Inquiry of Approval Officer Andy Cumming for documents that he relied on in coming to the decision on file LA19036, other than what is in the CFO database or Technical Document LA19036. This inquiry yielded a few e-mail communications that are not referenced in the database, but do appear in the Application Record Index.
