Stephanie and Adria,

I have reviewed the deemed complete package for Application LA19036, Arie & Willemina Muilwijk and have the following comments:

- 1) According to Part 2 – Technical Requirements section of the NRCB application the Arie & Willemina Muilwijk have signed Option 4: Uncertain if Water Act licence is needed; acknowledgement of risk (for existing CFO's only). No water use numbers or licence(s) have been submitted as part of the application to verify this statement.
- 2) According to Land Titles, the NE-10-009-27-W4M is within the Lethbridge Northern Irrigation District (LNID).

In discussion with the Lethbridge Northern Irrigation District (LNID) it was determined that Arie & Willemina Muilwijk at present DO NOT have an agreement with the District for the

delivery of water.

The LNID did comment that at present there is additional water available for purchase from the district, however, Arie & Willemina Muilwijk would be responsible for contacting the irrigation district to discuss obtaining an agreement for the delivery of water to their quarter, if they so choose.

- 3) A review of Alberta Water Well Information Database indicates two water wells (i.e. Well I.D. #'s 115734 and 115735) exist on the NE-10-009-27-W4M, however, the Alberta Environment and Parks Water Licence Viewer appears to indicate that neither surface water nor groundwater licences exist for this quarter, including for the water wells noted above. **The diversion of water from either of these water wells without a licence is a contravention of the *Water Act*.**

- 4) **Prior to any expansion and diversion of water Arie & Willemina Muilwijk must contact Alberta Environment and Parks to discuss legal options for the diversion of water for their proposed development.**
