# Notice Filed Requests for Board Review and Rebuttal Opportunity Decision Summary RA21045 G&S Cattle Ltd.

The Natural Resources Conservation Board (the Board) has received seven requests for review (RFR) on NRCB approval officer's Decision Summary RA21045 / G&S Cattle Ltd., issued on August 31, 2022. The decision summary denied an application for a new 4,000 beef finisher confined feeding operation (CFO). The proposed CFO is located at NW 3-47-2 W5M in Wetaskiwin County.

The RFRs received were from G&S Cattle Ltd.; the Summer Villages of Grandview, Poplar Bay, Crystal Springs, Norris Beach, and Ma-Me-O Beach; and John and Verna Phippen., and were filed by the September 22, 2022 deadline set out in the approval officer's decision letter. The RFRs are on the NRCB website project page.

Any directly affected party that believes they would be adversely affected by the positions presented in the RFRs may submit a written rebuttal for the Board's consideration [see section 13(4) of the AOPA Administrative Procedures Regulation].
