Notice Filed Requests for Board Review and Rebuttal Opportunity Decision Summary LA22029 Hutterian Brethren of Parkland

The Natural Resources Conservation Board (the Board) has received three requests for review (RFR) on Decision Summary LA22029 / Hutterian Brethren of Parkland. The NRCB approval officer issued the decision approving an application for a new poultry confined feeding operation (CFO) on September 7, 2022. The proposed CFO is located at SW 32-15-26 W4M in the Municipal District of Willow Creek.

The RFRs filed were from Hans Lievaart, Berger Land and Cattle Co. Ltd., and Jared and Kirby Duyns, and met the September 28, 2022 deadline set out in the approval officer's decision letter. The RFRs are publicly available on the NRCB website <u>project page</u>.
