## Notice Filed Request for Board Review and Rebuttal Opportunity Decision Summary RA22026 Rimrock Cattle Company Ltd.

The Board of the Natural Resources Conservation Board (NRCB) has received one request for review (RFR) on an NRCB approval officer's Decision Summary RA22026, issued on March 2, 2023. That decision denied an application by Rimrock Cattle Company Ltd. to expand its confined feeding operation (CFO) by increasing livestock numbers from a combination of 7,000 beef feeders and 7,000 beef finishers, to a total of 28,000 beef finishers (and no beef feeders). The existing CFO is located at Section 28-29-25 W4M in Kneehill County, roughly two kilometres east of the Village of Acme.

The RFR filed was from the operator, Rimrock Cattle Company Ltd., and met the March 23, 2023 deadline set out in the approval officer's decision letter. The RFR is publicly available <u>online</u> on the NRCB website.

Any directly affected party who has an **adverse** interest to the outcomes requested or to the positions presented in the RFR may submit a written rebuttal letter or email for the Board's consideration [section 13(4) of the AOPA Administrative Procedures Regulation]. Rebuttals must be sent by email to <a href="mailto:laura.friend@nrcb.ca">laura.friend@nrcb.ca</a> no later than **4:30 p.m. on March 30, 2023.** Rebuttals filed after the deadline will not be considered.
