In consideration of Decision Summary RA24001, Approval RA24001 is issued to:

Permitted construction (based on the submitted site plan):

- North runoff control catch basin – 40 m x 70 m x 4 m
- South runoff control catch basin – 41 m x 40 m x 4 m
- Livestock pens 8 and 9 - 62.5 m x 52.4 m each (part of the south livestock pens)

Permitted already constructed facilities (based on the submitted site plan):

- North livestock pens – 335 m x 137 m
- South livestock pens – 198 m x 274 m (pens 8 and 9 have not been constructed yet).

The permit holder shall comply with the requirements of the *Agricultural Operation Practices Act* (AOPA) and the regulations passed pursuant to that Act.

The permit holder shall adhere to the descriptions, the site plan, building plans, operating plan, engineering reports and other attached documents included with filed Application RA24001.

The permit holder shall contact the NRCB at least 10 working days in advance of the desired inspection date to schedule the inspection in conditions 1, 3, and 5.

Construction conditions

North catch basin

1. The permit holder shall not allow manure impacted runoff in the north runoff control catch basin, until the facility has been inspected by NRCB personnel and confirmed by them, in writing, to have been constructed in accordance with the terms and conditions of this permit.
2. The permit holder shall complete construction of the manure collection and storage portions of the north runoff control catch basin prior to November 30, 2025. Upon request, this deadline may be extended by the NRCB in writing.

South catch basin

3. The permit holder shall not allow manure impacted runoff in the south runoff control catch basin, until the facility has been inspected by NRCB personnel and confirmed by them, in writing, to have been constructed in accordance with the terms and conditions of this permit.



4. The permit holder shall complete construction of the manure collection and storage portions of the south runoff control catch basin prior to November 30, 2025. Upon request, this deadline may be extended by the NRCB in writing.

Livestock pens 8 and 9

5. The permit holder shall not allow livestock or place manure in livestock pens 8 and 9 until the facilities have been inspected by NRCB personnel and confirmed by them, in writing, to have been constructed in accordance with the terms and conditions of this permit.
6. The permit holder shall complete construction of the manure collection and storage portions of livestock pens 8 and 9 prior to November 30, 2025. Upon request, this deadline may be extended by the NRCB in writing.

This approval becomes effective immediately. The approval conditions will remain in effect unless amended in writing by the NRCB.
