# NRCB Notice Filed Requests for Board Review and Rebuttal Opportunity Decision Summary BA25008 Amin Valji

The Board of the Natural Resources Conservation Board (NRCB) has received five requests for review (RFRs) of an NRCB approval officer's Decision Summary BA25008, issued on August 15, 2025. The decision approved an application by Amin Valji to change the livestock category from 1,000 beef finishers to 115,000 layers and 115,000 pullets, and to construct barns and manure pads at an existing confined feeding operation (CFO). The existing CFO is located at SW 12-55-27 W4M in the Sturgeon County.

The RFRs were filed by directly affected parties and met the September 8, 2025, deadline set out in the approval officer's decision letter. The RFRs are available <u>online</u> on the NRCB website.

Any directly affected party who has an **adverse** interest to the outcomes requested or to the positions presented in the RFRs may submit a rebuttal (i.e., a written letter or email) for the Board's consideration (see section 13(4) of the AOPA Administrative Procedures Regulation).
