Re: Alberta Transportation - Springbank Off-Stream Reservoir Project **NRCB Application 1701**

Further to above captioned matter, please find attached the Springbank Off-Stream Project Preliminary Design Report ("PDR"). The attached is a further iteration of the Interim Design Report which was filed with the Natural Resources Conservation Board ("Board") in November 2017.

The attached PDR represents the most current overview of the project design, in light of additional data, stakeholder outreach and regulatory input, all of which has been received since 2017. These updates reflect expected changes in the development of a major project. Further, any changes in design that have the potential for environmental impacts have been considered and already addressed as part of the Supplemental Information Request ("SIR") process in the introduction to Alberta Transportation's responses to Round 2 SIRs dated June 23, 2020.

Final design will be set following the conclusion of the regulatory process and review and approval by the appropriate provincial bodies. Alberta Transportation continues to monitor the construction costs of the project. As noted in its June 14, 2019 letter to the NRCB, final
