## **INTRODUCTION**

The Stoney Nakoda Nations, also known as the Stoney Indian Band, are comprised of the Bearspaw, Chiniki, and Wesley First Nations and all of their members (the "Stoney Nakoda Nations").

The Stoney Nakoda Nations oppose the granting of Application No. 1701 (the "Application"). It is the position of the Stoney Nakoda Nations that the proposed Springbank Off-Stream Reservoir Project would have significant impacts on the rights and interest of the Stoney Nakoda Nations.

### **SUMMARY**

The Stoney Nakoda Nations are an Indian Band under the *Indian* Act, R.S.C. 1985 c.I-5. The members of the Stoney Nakoda Nations are all "Indians" within the meaning of section 91(24) of the *Constitution* Act, 1867, the *Constitution* Act, 1930 and the *Constitution* Act, 1982, and are Treaty Indians under Treaty No. 7 and "Aboriginal Peoples" within the meaning of the *Constitution* Act, 1982 and notably section 35 thereof. As such, the Stoney Nakoda Nations hold Aboriginal and Treaty rights in the area where the Proposed Project will be implemented. The proposed Project poses many environmental effects for the Stoney Nakoda Nations.

These environmental effects include the areas of health and the current use of lands and resources. The waters flowing through the traditional lands of the Stoney Nakoda have sustained the Stoney Nakoda people since time immemorial. When Treaty 7 was signed, the Stoney Nakoda neither surrendered their Aboriginal title to water within their traditional territory nor surrendered any other interests pursuant to an associated Aboriginal right. The Stoney Nakoda continue to hold these rights. Therefore, the Stoney Nakoda are concerned that the project will impact these rights and traditional use of lands in the Project area.

The purpose or benefit of the proposed project is to provide flood protection to the City of Calgary. However, there will be no benefits from the Project unless similar flood protection is not also provided on the Bow River.

The stated purpose of the Project is not attainable. Reducing flood risk on the Elbow River will do nothing for downstream communities, *viz*. the City of Calgary, if equivalent flood mitigation measures are not also implemented on the Bow River upstream of the City of Calgary.
