

# Natural Resources Conservation Board

## Business Plan 2015-2018

The Natural Resources Conservation Board (NRCB) is an independent, quasi-judicial and regulatory agency of the Government of Alberta. It is accountable to the Minister of Environment and Parks and is responsible for reviews of natural resource projects under the *Natural Resources Conservation Board Act*, and regulating Alberta's confined feeding industry under the *Agricultural Operation Practices Act*.

The Natural Resources Conservation Board Act is the responsibility of Environment and Parks.

The Agricultural Operation Practices Act is the responsibility of Agriculture and Forestry. A 2006 memorandum of understanding between the Minister of Sustainable Resource Development, the Minister of Agriculture and Rural Development, the Chair, and the Chief Executive Officer of the Natural Resources Conservation Board describes the purpose of the act, and governance and mandate responsibilities.

## STRATEGIC PRIORITIES

The Natural Resources Conservation Board has identified the following strategic priorities for 2015-18:

- 1. Cross government initiatives Linkage: goals one and two
- 2. Consistent delivery of the Agricultural Operation Practices Act Linkage: goal two
- 3. Risk based approach to regulating confined feeding operations Linkage: goal two
- 4. Board procedures and public information Linkage: goal one

- Continue to support priority Government of Alberta initiatives such as Water for Life, the Clean Air Strategy and the Land-use Framework.
- Coordinate with government and stakeholders on operational policy and technical guidelines to support consistent delivery of the act. Operational policy will include a comprehensive update and amalgamation of relevant approval policies.
- Continue to use an environmental risk based approach for compliance activities at confined feeding operations and for reviewing permit applications for new or expanding operations.
- Update board regulations and information documents in consultation with stakeholders.

### CORE BUSINESSES: GOALS, STRATEGIES AND PERFORMANCE MEASURES

## Core Business One: Board reviews and appeals under the *Natural Resources Conservation Board Act* and the *Agricultural Operation Practices Act.*

#### Goal one

Natural Resources Conservation Board reviews and hearings result in balanced decisions and are conducted in a manner that is effective, fair, transparent and timely.

#### What it means

The Board conducts reviews of proposed natural resource projects under the *Natural Resources Conservation Board Act* to determine whether the projects are in the public interest, having regard for their environmental, social and economic impact. Reviews are mandatory for non-energy mining, forestry, water management or recreation projects for which an environmental impact assessment is required under the *Environmental Protection and Enhancement Act.* Projects may also be referred to the board by Order in Council.

Under the Agricultural Operation Practices Act, the Board must determine whether to grant a request for a review of a permitting or compliance decision. Should the Board grant a review, it may be oral, electronic or written. The Board may also recommend mediation.

- **Strategies** 1.a Update the Board Administrative Procedures Regulation in consultation with NRCB staff and stakeholders.
  - 1.b Proactively provide opportunities for all participants to understand NRCB review and hearing processes through guides, public information sessions, and prompt, accurate responses to direct inquiries.
  - 1.c Identify critical issues related to applications under the *Natural Resources Conservation Board Act*, to ensure that relevant information is included in the review process. This information is essential to ensuring that reviews are effective, fair and transparent.
  - 1.d Ensure that natural resource projects and confined feeding operation permit application reviews are consistent with regional land use plans under the *Alberta Land Stewardship Act*.

### Core Business Two: Regulation under the Agricultural Operation Practices Act

#### Goal two

Effective and efficient permitting and compliance processes for confined feeding operations and manure management.

#### What it means

The Natural Resources Conservation Board regulates confined feeding operations in Alberta under the *Agricultural Operation Practices Act*. It consults with the multi-stakeholder Policy Advisory Group on priority issues and operational policy development. All permitting decisions address consistency with regional land use plans.

The board ensures that new and existing confined feeding operations meet the legislated requirements of the *Agricultural Operation Practices Act*, delivers a risk based compliance program, ensures that existing operations are compliant with the act and their permits, and investigates and responds to complaints.

- **Strategies** 2.a Deliver timely communications for confined feeding operators and key stakeholders on NRCB initiatives, policies and programs.
  - 2.b Develop new and update existing operational policies in consultation with the Policy Advisory Group including policies on waivers, denying applications with incomplete information, and amendments of municipal permit conditions.
  - 2.c Consult with government and the Policy Advisory Group on key issues and policy for responding to requests for permission to apply manure to frozen or snow covered land.
  - 2.d Support other departments and agencies studying the effects of manure collection and storage facilities on groundwater quality.
  - 2.e Consult with Agriculture and Forestry and the Policy Advisory Group to finalize the parameters used to determine the status of a site as a seasonal feeding and bedding site or as a confined feeding operation.
  - 2.f Complete the design of and implement a three-year program to review all water well monitoring conditions in *Agricultural Operation Practices Act* permits.
  - 2.g Document surface water conditions at confined feeding operations. Use the data collected to inform future compliance response for surface water issues. Continue to standardize the collection of surface water information and ensure appropriate follow-up action.
  - 2.h Continue to audit results from environmental risk screenings to maintain quality and ensure consistent risk determinations.
  - 2.i Continue upgrades to the confined feeding operation database to improve the efficiency of data entry and retrieval. Use quarterly exception reports to monitor the management and entry of data on the database.
  - 2.j Work with the Technical Advisory Group to develop technical guidelines that support delivery of the *Agricultural Operation Practices Act*.
  - 2.k Review internal permit review processes and timelines.
  - 2.I Ensure that confined feeding applications are consistent with regional land use plans under the *Alberta Land Stewardship Act*.

#### Goal three

The Natural Resources Conservation Board has the expertise and technical resources required to fulfill its mandates under the *Natural Resources Conservation Board Act*, and the *Agricultural Operation Practices Act*.

#### What it means

Staff and Board members of the Natural Resources Conservation Board work with diverse issues requiring detailed technical knowledge. Staff and Board members are highly trained, competent and motivated to deliver high standards of service.

The Natural Resources Conservation Board is committed to effective internal communications to build teamwork and a shared understanding throughout the organization of its values and mandate.

**Strategies** 3.a Provide appropriate training in areas of required professional development.

- Management will review critical training requirements on a divisional basis in 2015/16.
- Identify opportunities for staff to lead in-house training for other employees.
- 3.b Examine the opportunities, challenges and resource implications for expanded web-based public access to Board review and decision documents.
- 3.c Conduct an in-house review of corporate records management needs.
- 3.d Maintain and continuously improve internal information technology tools.
  - Investigate the strategies and costs of a records management system for the NRCB's print and electronic records.
  - Research the use of IT system improvements and new software to automate corporate services functions, where appropriate.
  - Expand the use and application of computer tablets by field staff to improve the quality and timeliness of field data collection associated with compliance and permitting activities.
