

Frequently Asked Questions: Public Disclosure of Travel and Expenses (updated February 2023)

1. Which NRCB positions are expenses disclosed for?

Expenses are disclosed for the NRCB's Chair, Board members and Chief Executive Officer.

2. What expenses are disclosed?

Costs and allowances incurred in the course of NRCB business:

- travel, including transportation, accommodation, meals and related incidentals
- hospitality and working sessions

3. What expense information is disclosed on the NRCB website?

The expense information includes:

- the name and position of the discloser
- the date of the transaction(s) giving rise to the expense
- the amount of each expense
- the category of each expense (for example, travel, including transportation, accommodation, meals and related incidentals; hospitality and working sessions)
- a description and the rationale for each expense
- receipts for each reimbursed expense where applicable

4. How often are expenses disclosed?

Expenses are disclosed and posted on the NRCB website on a monthly basis, by the first business day of the following month in which the expense claim is reimbursed.

5. Why is no expense information posted under a particular reporting period for some individuals?

No expenses were incurred or processed for that individual during that reporting period.

7. Why is there no receipt for an expense?

A receipt is not required for a reimbursement of an expense for which an allowance can be claimed. This includes expenses such as per diems, meal allowances, mileage claims, and meter parking.
