**Permitted construction** (based on the submitted site plan):

- Broiler barn (Barn 3) – 76.2 m x 18.3 m

The co-permit holders shall comply with the requirements of the *Agricultural Operation Practices Act* (AOPA) and the regulations passed pursuant to that Act.

The co-permit holders shall adhere to the descriptions, the site plan, building plan and other attached documents included with filed Application RA24027. Authorization RA12033, must also be adhered to unless otherwise noted in the following conditions.

The co-permit holders shall contact the NRCB at least 10 working days in advance of the desired inspection date to schedule the inspection in condition 2.

The co-permit holders are responsible for all costs associated with reporting requirements (this includes post construction reports).

### **Construction conditions**

#### Broiler Barn

1. The concrete used to construct the liner of the manure collection and storage portion of the new broiler barn shall meet the specification for category D (solid manure – dry) in Technical Guideline Agdex 096-93 “Non-Engineered Concrete Liners for Manure Collection and Storage Areas.” The co-permit holders shall provide documentation to confirm the specifications of the concrete used to construct the manure storage and collection portions of the broiler barn.
2. The co-permit holders shall not allow livestock or manure in the new broiler barn until the facility has been inspected by NRCB personnel and confirmed by them, in writing, to have been constructed in accordance with the terms and conditions of this permit.
3. The co-permit holders shall complete construction of the manure collection and storage portions of the new broiler barn prior to November 1, 2025. Upon request, this deadline may be extended by the NRCB in writing.

This registration becomes effective immediately. The registration conditions will remain in effect unless amended in writing by the NRCB.

Authorization RA12033 and the deemed registration are hereby superseded, and their content consolidated into this Registration RA24027, unless Registration RA24027 is held invalid following a review and decision by the NRCB's board members or by a court, in which case Authorization RA12033 and the deemed registration will remain in effect.
