Permitted construction (based on the submitted site plan):

- Replacing the concrete liner in existing barn (barn conversion) 70.8 m x 22.2 m
- Solid manure pad 24.4 m x 22.8 m

The permit holder shall comply with the requirements of the *Agricultural Operation Practices Act* (AOPA) and the regulations passed pursuant to that Act.

The permit holder shall adhere to the descriptions, the site plan, building plans and other attached documents included with filed Application RA25011.

The permit holder shall contact the NRCB at least 10 working days in advance of the desired inspection date to schedule the inspection in conditions 3 and 7.

The permit holder is responsible for all costs associated with recording and reporting requirements (this includes post construction reports).

Construction conditions

Barn conversion

- The concrete used to construct the liner of the manure collection and storage portions of the barn renovation shall meet the specification for category D (solid manure – dry) in Technical Guideline Agdex 096-93 "Non-Engineered Concrete Liners for Manure Collection and Storage Areas".
- The permit holder shall provide documentation to confirm the specifications of the concrete used to construct the manure storage and collection portions of the barn conversion.
- 3. The permit holder shall not allow livestock or manure in the converted barn until the facility has been inspected by NRCB personnel and confirmed by them, in writing, to have been constructed in accordance with the terms and conditions of this permit.
- 4. The permit holder shall complete construction of the manure collection and storage portions of the barn conversion prior to March 30, 2028. Upon request, this deadline may be extended by the NRCB in writing.



Solid manure pad

- 5. The concrete used to construct the liner of the manure collection and storage portions of the new solid manure pad shall meet the specification for category C (solid manure – wet) in Technical Guideline Agdex 096-93 "Non-Engineered Concrete Liners for Manure Collection and Storage Areas".
- 6. The permit holder shall provide documentation to confirm the specifications of the concrete used to construct the manure storage and collection portions of the solid manure pad.
- 7. The permit holder shall not place manure on the new solid manure pad until the facility has been inspected by NRCB personnel and confirmed by them, in writing, to have been constructed in accordance with the terms and conditions of this permit.
- 8. The permit holder shall complete construction of the manure collection and storage portions of the solid manure pad prior to March 30, 2028. Upon request, this deadline may be extended by the NRCB in writing.

This registration becomes effective immediately. The registration conditions will remain in effect unless amended in writing by the NRCB.
