**Re: Enforcement Order EO 25-03 – Extensions
SE 2-35-17 W4M**

On June 16, 2025, I issued Enforcement Order No. EO 25-03 in relation to a hybrid swine operation at this site ("EO 25-03"). In this letter, I extend two deadlines contained in EO 25-03.

Extension of date in Order 1

The Orders of EO 25-03 provide you with two choices to come into compliance, each set out in a separate Order. Order 1 requires, as one option for compliance,

1. By July 15, 2025, provide a plan to the NRCB which describes in detail how pens P1B – P19B (EO 25-03 Appendix B) will be managed to return these pens to a rotational grazing system. The detailed plan shall:
 - a. identify how vegetation will successfully re-establish (seeded) and be maintained during the growing seasons,
 - b. the type of crop or vegetation that will be used in returning the pens to a vegetated state,
 - c. include an animal rotation strategy that is based on vegetation grow stage or timelines to ensure adequate vegetation is established and maintained in the pens as animals are moved in and out during the growing season,
 - d. include an animal rotation strategy utilized during the non-growing season (overwinter),
 - e. timelines for the establishment of the vegetation and the commencement of rotational grazing system both initially and going forward, and be approved in writing by the NRCB prior to implementation;

I am extending the deadline in Order 1 from July 15, 2025, to **July 29, 2025**. As explained in EO 25-03, deadline dates contained above may be extended only by the NRCB, and at the sole discretion of the NRCB. Please note the receipt of one extension does not provide justification for another.

The other option, set out in Order 2, is to depopulate and remove manure from pens P1B – P19B (EO 25-03 Appendix B), if an NRCB permit has not been issued for this site. For clarity, that deadline **remains at January 15, 2026**.

Extension of deadline to apply for a Request for Review

Page 6 of 6 of EO 25-03 outlines information on the right to request a review of EO 25-03. The deadline to request a review from the NRCB Board of EO 25-03 is identified as 4:30 p.m. on June 30, 2025.

Under section 15(2) of the AOPA Administrative Procedures Regulation, I am amending EO 25-03 to **extend the deadline to request a review with the NRCB Board** from June 30, 2025, at 4:30 p.m. **to July 9, 2025, at 4:30 p.m.** By way of copying Laura Friend (Manager, Board Reviews) on this letter, I am advising the NRCB Board of this extended deadline.
