Permitted construction (based on the submitted site plan):

• Broiler breeder barn 5 – 51 m x 13.4 m

The permit holder shall comply with the requirements of the *Agricultural Operation Practices Act* (AOPA) and the regulations passed pursuant to that Act.

The permit holder shall adhere to the descriptions, the site plan, building plans, and other attached documents included with filed Application BA25013 and associated permits Approval BA16017 and Authorizations BA21016, BA23002, and BA25002.

The permit holder shall contact the NRCB at least 10 working days in advance of the desired inspection date to schedule the inspection in condition #3.

Construction conditions

Broiler breeder barn

1. Construction completion deadline

The permit holder shall complete construction of broiler breeder barn 5 prior to December 1, 2026. Upon request, this deadline may be extended by the NRCB in writing.

2. Concrete

The concrete used to construct the manure collection and storage liner of broiler breeder barn 5 must meet the specifications for category D (solid manure – dry) in Technical Guideline Agdex 096-93 "Non-Engineered Concrete Liners for Manure Collection and Storage Areas." The permit holder shall provide written proof to the NRCB confirming the specifications of the concrete used. This document must be provided to the NRCB prior to the inspection referenced in condition #3, below, or by a later date stated by the NRCB.

3. Post construction inspections (prior to populating facilities) The permit holder shall not place livestock or manure in broiler breeder barn 5 until the NRCB has inspected the facility and stated in writing that it has been constructed in accordance with this approval.

This Approval becomes effective immediately. The Approval conditions will remain in effect unless amended in writing by the NRCB.



Previously issued, Approval BA16017 and Authorizations BA21016, BA23002, and BA25002 are hereby superseded, and their content consolidated into this Approval BA25013, unless Approval BA25013 is held invalid following a review and decision by the NRCB's board members or by a court, in which case Approval BA16017 and Authorizations BA21016, BA23002, and BA25002 will remain in effect.

Construction conditions (brought forward from old permits)

Approval BA16017

1. Construction completion deadline

The permit holder shall complete construction of the broiler breeder barn extension prior to December 1, 2020. Upon request, this deadline may be extended by the NRCB in writing.

2. Concrete

The concrete used to construct the liner of the broiler breeder barn must have a minimum 28-day strength of 25 MPa. The permit holder shall provide written confirmation from a qualified third party confirming the concrete used for the manure collection and storage area meet the required specification. The permit holder shall provide this documentation to the NRCB prior to the inspection referenced in condition 3 below or by a later date stated by the NRCB.

3. Post construction inspection

The permit holder shall not allow livestock or manure in the entire broiler breeder barn until the facility has been inspected by NRCB personnel and determined by them in writing, to have constructed in accordance with the terms and condition of this permit.

Authorization BA21016

1. Construction completion deadlines

The permit holder shall complete construction of the rooster barn prior to December 1, 2023. Upon request, this deadline may be extended by the NRCB in writing.

2. Concrete

The concrete used to construct the manure collection and storage liner of the rooster barn must meet the specifications for category D (solid manure dry), in Technical Guideline Agdex 096-93 "Non-Engineered Concrete Liners for Manure Collection and Storage Areas." The permit holder shall provide written proof to the NRCB confirming the specifications of the concrete used. This document must be provided to the NRCB prior to the inspection referenced in condition #3, below, or by a later date stated by the NRCB.



3. Post construction inspections (prior to populating facilities)

The permit holder shall not place manure or livestock in the rooster barn until the NRCB has inspected the facility and stated in writing that it has been constructed in accordance with this approval.

Authorization BA23002

4. Construction completion deadline

The permit holder shall complete construction of the addition to broiler breeder barn 3 prior to December 1, 2024. Upon request, this deadline may be extended by the NRCB in writing.

5. Concrete

The concrete used to construct the manure collection and storage liner of the addition to broiler breeder barn 3 must meet the specifications for category D (solid manure – dry) in Technical Guideline Agdex 096-93 "Non-Engineered Concrete Liners for Manure Collection and Storage Areas." The permit holder shall provide written proof to the NRCB confirming the specifications of the concrete used. This document must be provided to the NRCB prior to the inspection referenced in condition #3, below, or by a later date stated by the NRCB.

6. Post construction inspections (prior to populating facilities) The permit holder shall not place livestock or manure in the addition to broiler breeder barn 3 until the NRCB has inspected the facility and stated in writing that it has been constructed in accordance with this authorization.

Authorization BA25002

7. Construction completion deadline

The permit holder shall complete construction of the addition to broiler breeder barn 2 prior to December 1, 2026. Upon request, this deadline may be extended by the NRCB in writing.

8. Concrete

The concrete used to construct the manure collection and storage liner of the addition to broiler breeder barn 2 must meet the specifications for category D (solid manure – dry) in Technical Guideline Agdex 096-93 "Non-Engineered Concrete Liners for Manure Collection and Storage Areas." The permit holder shall provide written proof to the NRCB confirming the specifications of the concrete used. This document must be provided to the NRCB prior to the inspection referenced in condition #3, below, or by a later date stated by the NRCB.

The permit holder shall not place livestock or manure in the addition to broiler breeder barn 2 until the NRCB has inspected the facility and stated in writing that it has been constructed in accordance with this authorization.
