The permit holder shall comply with the requirements of the *Agricultural Operation Practices Act* (AOPA) and the regulations passed pursuant to that Act.

The permit holder shall adhere to the descriptions, the site plan, operating plan, and other attached documents included with filed Application BA25007 and associated deemed Registration PB22001 and Authorization BA23001.

The permit holder shall contact the NRCB at least 10 working days in advance of the desired inspection date to schedule the inspection in conditions 3 and 6.

The permit holder is responsible for all costs associated with monitoring, sampling, testing, recording, and reporting requirements (this includes post construction reports).

Construction conditions (brought forward from Authorization BA23001)

Chicken layer barn

Construction completion deadline
 The co-permit holders shall complete construction.

The co-permit holders shall complete construction of the chicken layer barn prior to December 1, 2026. Upon request, this deadline may be extended by the NRCB in writing.

2. Concrete

The concrete used to construct the manure collection and storage liner of the chicken layer barn must meet the specifications for category D (solid manure - dry) in Technical Guideline Agdex 096-93 "Non-Engineered Concrete Liners for Manure Collection and Storage Areas." The co-permit holders shall provide written proof to the NRCB confirming the specifications of the concrete used. This document must be provided to the NRCB prior to the inspection referenced in condition #3, below, or by a later date stated by the NRCB.

3. Post construction inspections (prior to populating facilities)
The co-permit holders shall not place livestock or manure in the chicken layer barn until the NRCB has inspected the facility and stated in writing that it has been constructed in accordance with this approval.

Compost shed

4. Construction completion deadline

The co-permit holders shall complete construction of the compost shed prior to December 1, 2026. Upon request, this deadline may be extended by the NRCB in writing.



5. Concrete

The concrete used to construct the manure collection and storage liner of the compost shed must meet the specifications for category D (solid manure - dry) in Technical Guideline Agdex 096-93 "Non-Engineered Concrete Liners for Manure Collection and Storage Areas." The co-permit holders shall provide written proof to the NRCB confirming the specifications of the concrete used. This document must be provided to the NRCB prior to the inspection referenced in condition #6, below, or by a later date stated by the NRCB.

Post construction inspections (prior to populating facilities)
 The co-permit holders shall not place manure in the compost shed until the NRCB has inspected the facility and stated in writing that it has been constructed in accordance with this approval.

Decommissioning of existing chicken layer barn

7. The co-permit holders shall decommission the existing chicken layer barn upon completion and transition to the new chicken layer barn, in accordance with Technical Guideline Agdex 096 – 90, "Closure of Manure Storage Facilities and Manure Collection Areas". Once decommissioning of the Grandfathered chicken layer barn is completed, the facility will no longer hold an AOPA permit and will not be allowed to house livestock or manure unless repermitted.

This Approval becomes effective immediately. The Approval conditions will remain in effect unless amended in writing by the NRCB.

Deemed Registration PB22001 and Authorization BA23001 are hereby superseded, and their content consolidated into this Approval BA25007, unless Approval BA25007 is held invalid following a review and decision by the NRCB's board members or by a court, in which case deemed Registration PB22001 and Authorization BA23001 will remain in effect.
